Decisions to be made by the Cabinet as a matter of urgency Date of Notice: 26th February 2015

Local authorities are required to publish a Notice of key decisions and/or of their intention to hold a meeting of the Executive ('the Cabinet') in private at least 28 clear days before the meeting. Legal advice is that Cabinet approval is needed to serve notice and complete on the transfer.
