

## Notice of Forthcoming Key Decisions and Decisions to be Taken in Private

Published in Accordance with the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012

## Decisions to be made by the Cabinet as a matter of urgency Date of Notice: 8<sup>th</sup> July 2016

Local authorities are required to publish a Notice of key decisions and/or of their intention to hold a meeting of the Executive ('the Cabinet') in private at least 28 clear days before the meeting. This Notice sets out decisions to be taken at the meeting of the Cabinet on 18<sup>th</sup> July 2016 which have not been included on previously published statutory notices (the Forward Plan). In accordance with the Regulations, the Chair of the Overview & Scrutiny has been informed of the matters to be considered at the meeting and where required has agreed that the key decision(s) can be taken.

Reason for urgency	Notice of a Part I key decision was included in the Notification of Forthcoming Key Decisions for this period, however, it has subsequently being agreed to include to include an Appendix that contains exempt information relating to the "prevention, investigation or prosecution of crime", which needs to be considered in private in Part II of the agenda. Provision was not made for the Part II Appendix, however, it is considered that deferring the decision is not in the public interest as doing so would cause unnecessary risk to the implementation timescales to assess all new claims using Risk Based Verification with effect from 1 October 2016.
