Section 84 of the Road Traffic Regulation Act 1984 and regulation 7 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996

A4 M4J5 to Sutton Lane 30mph Speed Limit Order 2021 (Order 27 of 2021) (Proposed Order)

1. Slough Borough Council gives notice that it proposes to make an Order under sections 84(1) and (2) of the Road Traffic Regulation Act 1984 and any other enabling powers. If the Order comes into force:
 - a. no person shall drive any motor vehicle at a speed exceeding 30 miles per hour on any road or length of road specified in the Schedule 1 to this notice; and
 - b. no person shall drive any motor vehicle at a speed exceeding 40 miles per hour on any road or length of road specified in the Schedule 2 to this notice.
2. The Order shall come into operation on the date on which notice that it has been made is first published.
3. This Order revokes any previous Orders imposing a speed limit on the lengths of road referred to in the Schedules to this Order in so far as they relate to the lengths of road referred to in Schedules 1 and Schedule 2/paragraph 1 to this Order.
4. Special forces drivers using vehicles in response to a national security emergency or whilst being trained or practicing to do so, and any vehicle being used for emergency services purposes are exempted from the speed limit imposed by this Order.

6. Introduction of 30mph Speed Limit

Road	Start and End Points
A4 (London Road / Colnbrook Bypass)	From its junction with the southeast arm of the M4J5 roundabout to a point 7 metres east of the eastern building line of the property at postcode SL3 8QQ
Sutton Lane	From its junction with the A4 to a point 57 metres north of its junction with the centre line of Trent Road
London Road	From its junction with the southeast arm of the A4/London Road/Colnbrook Bypass junction to a point 7 metres east of the west building line of No 602 London Road

Schedule 2

Introduction of 40mph Speed Limit

Road	Start and End Points
A4 (Colnbrook Bypass)	From a point 7 metres east of the eastern building line of the property at postcode SL3 8QQ to a point 60 metres east of its junction with the centre line of McArdle Way
