



**SLOUGH BOROUGH COUNCIL

COMPULSORY PURCHASE ORDER 2020**

**The Housing Act 1985
and the Acquisition of Land Act 1981**

The **SLOUGH BOROUGH COUNCIL** (in this order called “the acquiring authority”) makes the following order:-

1. Subject to the provisions of this order, the acquiring authority is under section 17(1)(b) of the Housing Act 1985 hereby authorised to purchase compulsorily the land described in paragraph 2 for the purpose of the provision of housing accommodation.

2. The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown edged red on a map prepared in duplicate, sealed with the Common Seal of the acquiring authority and marked “Map referred to in the Slough Borough Council (6 Carlisle Road) Compulsory Purchase Order 2020.”

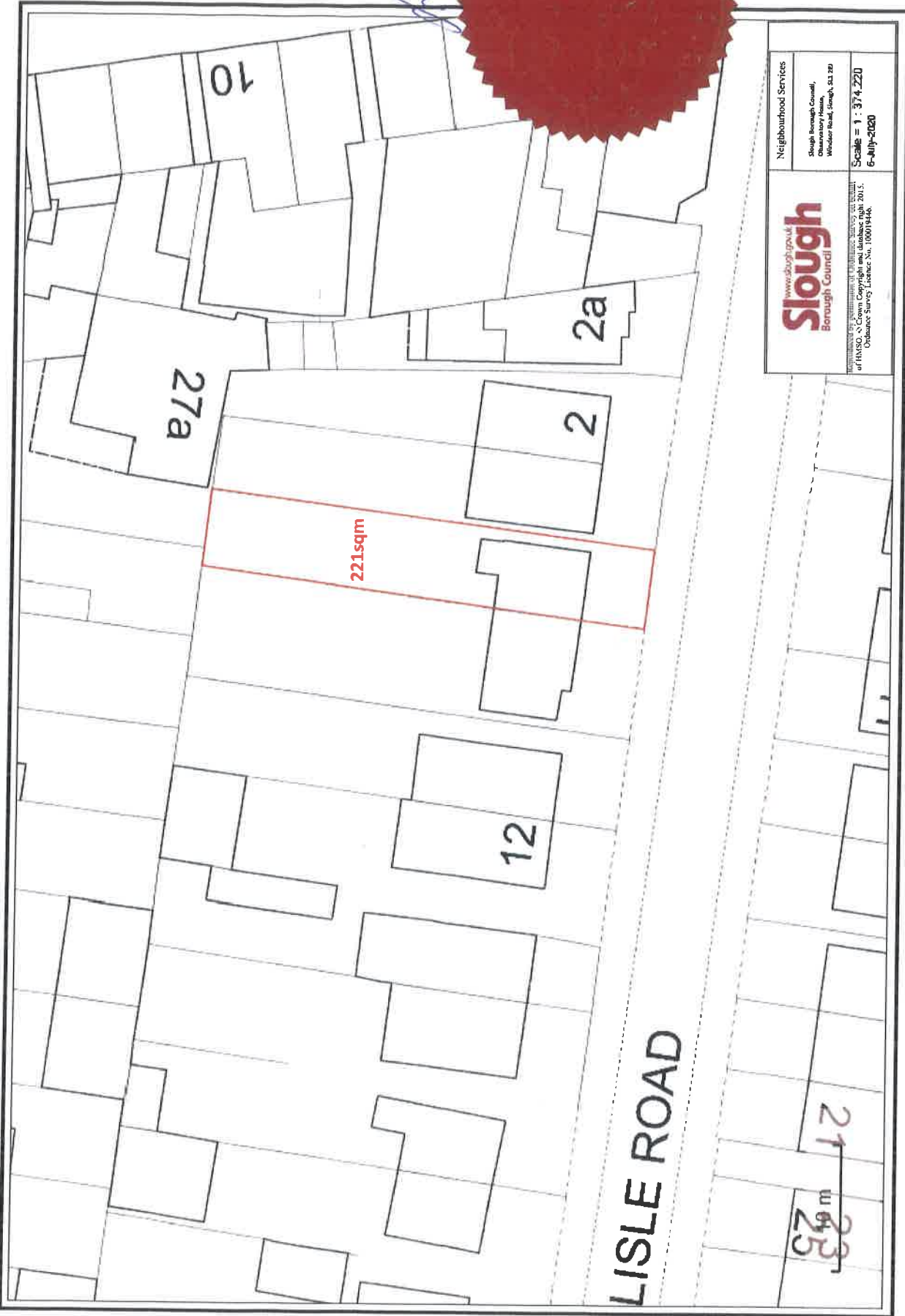
