

## The New Slough Learning Disability Partnership Board Inaugural Meeting - 21<sup>st</sup> February 2024 Observatory House, Slough





### Welcome and introductions.

GDM apologised for the late start and expressed gratitude in seeing several experts by experience present.

• GDM explained that this is a forum for people with learning disability community.

• GDM introduced himself and welcomed the new Learning Disability partnership board members before starting with

members' introductions.

- Members then introduced each other.
- There was a good collaborative and cheerful atmosphere



## The New Learning Disability Partnership Board – Presentation

- GDM shared a presentation to introduce the new Partnership Board to all members.
- MG commented the need for better wording to say *"preventing needs to arise..."* which may be misunderstood.

- SB commented that the wording should be more specific and recognise the people with LD, their carers, and some priorities such as housing.
- EC echoed that some important key actions did not appear in the presentation, such as housing and transports.
- GDM clarified that the presentation was a short summary and not a fully exhaustive description of the Partnership work.

#### Actions: Wording to be reviewed.



### The New Learning Disability Partnership Board – Terms of Reference Exercise

- GDM introduced the first group exercise that was about reading paragraphs from the Terms of Reference, and find agreement on references or amendments needed.
- Members said that the printed copies may have not been enough. Therefore, BB and AH promptly printed additional copies.
- EC pointed out that the group was too big for a discussion and that the group prefers to break down in smaller units to discuss.
- EC also pointed out that the meeting was already late.
- Groups of four people were made and 15 minutes were provided for discussion before getting back together for feedback.
- Unfortunately, the document was very big and the time too few for a thorough discussion. Many other participants agreed.
- The group agreed that GDM will send a copy of the document and that comments will be provided via email or at the next meeting.
- Feedback provided were about a clearer definition of who are the stakeholders and who are the beneficiaries,
- Another feedback was that there should be a lesson learned approach and review of what has gone wrong in the past
- Another feedback was about finding strategies to reach all client groups, and look at alternative ways to fund initiatives (sponsorship, crowdfunding, etc).
- There was a positive working atmosphere among board members

#### Actions: GDM to share the Terms of Reference. All Members to share feedback via email or in person at next meeting.

# The New Learning Disability Partnership Board – The Learning Disability Strategy 2023-2028 (Presentation)

- GDM shared a presentation about the Learning Disability Strategy 2023-2028. and a brief summary of actions in the Strategy.
- Members commented that it would be useful to have a definition of learning disabilities and it was clarified that the Strategy provides a definition.
- EC, SB, and GB commented that some priorities and actions were too vague and needed to be more specific.
- EC noted that important priorities and actions concerning housing or transports were not in the presentation.
- GDM clarified that the presentation only had 6 wide areas for actions rather than specific actions because the Group will create specific actions.
- GDM reassured members that the presentation is only a short summary and that the full document goes into the details of each priority.
- An action plan is available at the end of the strategy and the group will decide what is more urgent.
- GDM informed all members that smaller workgroups will be created. These groups will be time limited and meet more regularly than the full board.

## Actions: GDM to provide clarification for LD definition (in new TOR draft) for the group.

GDM to provide list of all actions included in the Learning Disability Strategy to members at next meeting.



The New Learning Disability Partnership Board – Workshop to identify most pressing priorities for actions.

- The second group exercise: In groups of four, members have looked at the 6 priority areas for action to decide the three most important issues. 15 minutes were provided for discussion.
- EC commented that the time provided was not sufficient to pick only three things.
- EC and their clients think that what it is more pressing are transports and housing but these are not in the presentation.
- More members agreed that the time provided was not sufficient.
- It was agreed to extend the feedback until next meeting and there will be a survey online to share ideas.
- Some other members felt they were ready to share the feedback from their group.
- A few people agreed that the main priorities should be: communication, transition health, employments.
- RK's group said that it is not possible to decide what comes first because these are important actions.
- Two other groups had a similar idea

Actions: GDM to add priority questions in feedback form when distributing the minutes. GDM to start circulating list of initial workstream groups to members to gather volunteers.
