**The borough of Slough Off-street parking places (consolidation) order 2017
(Amendment no. 38) Order 2024 (Order 27 of 2024) (“Order”)**

**Sections 32, 33 and 35 of the Road Traffic Regulation Act 1984 and Regulation 22 of
the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations
1996.**

1. Slough Borough Council makes this Order in exercise of its powers under sections 32, 33 and 35 of the Road Traffic Regulation Act 1984 and any other enabling powers.
2. The Order shall come into operation on the date the notice of making is first published.
3. While the Order is in operation, the Borough of Slough Off-Street Parking Places (Consolidation) Order 2017 (‘the 2017 Order’) shall be amended as follows:-
 - (a) Schedule 1 to the 2017 Order is deleted in its entirety and is replaced with Schedule A to this Order;
 - (b) Schedule 2 to the 2017 Order is deleted in its entirety and is replaced with Schedule A to this Order.

Statement Of Reasons

The Council's budget review identified that it was necessary to increase parking fees and charges to meet rising costs, including those for the Borough's car parks. There had been significant increases in inflation and maintenance costs for the car parks, the off street charges had not been revised since 2021.

Furthermore, with the Council's aspiration to promote alternative modes of transport and changing travel behaviour, it was necessary to take into account these aspects as well as the increased costs of running the service.

The review was based on extensive analysis of data and the outcome of the Council's Parking Strategy. Factors considered included time of parking, customer behaviour, locality (majority of these tariffs are in the Town Centre and serve businesses), trends including duration of parking, extension of parking time, payment methods being utilised and strategic classification of short and long term parking.
