(b) The items set out in Schedule B to this Order are added to Schedule 8.01 to the 2017 Order; and


(c) The items set out in Schedule C to this Order are added to Schedule 8.02 to the 2017 Order.

Statement of reasons

This Order creates the CP Zone parking scheme incorporating the South Western Arm of London Road, located outside Nos. 560 to 578.

The purpose of these changes is to prevent traffic congestion and avoiding danger to persons or other traffic using the road and preventing the likelihood of such danger arising, while providing convenient parking facilities for local residents, businesses and their visitors. Further aims are to promote sustainability and improve air quality by encouraging commuters to use alternatives to the private car.
