The Borough of Slough Waiting Restrictions and Parking Places (Consolidation) Order 2017 (Amendment No. 34) Order 2023 (Order 10 of 2024) ("Order")

Sections 1, 45, 46 and 53 of the Road Traffic Regulation Act 1984. Regulation 7 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 (as amended).

1. Slough Borough Council makes this Order in exercise of its powers under sections 1, 45, 46 and 53 of the Road Traffic Regulation Act 1984 and any other enabling powers.
2. This Order shall come into operation on the date on which its notice of making is first published.
3. While the Order is in operation, the Slough Borough Council Waiting Restrictions and Parking Places (Consolidation) Order 2017 ('the 2017 Order') shall be amended as follows:

The borough of Slough Waiting restrictions and parking places (consolidation) Order 2017 (Amendment No. 34) Order 2024 (Order 10 of 2024)

Statement Of Reasons

This Order creates the K1 Zone parking scheme covering parts of Mill Street, parts of Petersfield Avenue, all of Benson Close and all Whitenham Close – see the zone area plan attached. In addition, the Order also:-

1. Amends restrictions on Albion Close, Mill Street, Petersfield Avenue, St. Pauls Avenue, Stoke Road and Whitenham Close.
2. Creates limited waiting bays on St. Paul's Avenue and Stoke Road.
3. Creates of pay by phone bays on Albion Close and Petersfield Avenue.
4. Creates of permit holders only bays partly on the footway on Petersfield Avenue.
5. Creates of Shared use permit only or limited waiting bays Mon – Sat 8am to 6pm - permit holders only outside these hours including Sunday on Whitenham Close

The purpose of these proposals is to prevent traffic congestion and avoiding danger to persons or other traffic using the road and preventing the likelihood of such danger arising, while providing convenient parking facilities for local residents, businesses and their visitors. Further aims are to promote sustainability and improve air quality by encouraging commuters to use alternatives to the private car.
