- f. The items set out in Schedule F to this Order are added to Schedule 8.01 to the 2017 Order.
- g. The items set out in Schedule G to this Order are added to Schedule 8.02 to the 2017 Order.

STATEMENT OF REASONS

This Experimental Order creates the BS2 Zone parking scheme covering all of Baylis Road, all of Bradley Road, all of Carmathen Road, all of Leeds Road and all of Oakley Crescent. In addition to this no waiting at any time and/ or limited waiting restrictions are being proposed in the above locations and also Pool Lane and part of Stoke Poges Lane.

The purpose of these proposals is to prevent traffic congestion and avoiding danger to persons or other traffic using the road and preventing the likelihood of such danger arising, while providing convenient parking facilities for local residents, businesses and their visitors. Further aims are to promote sustainability and improve air quality by encouraging commuters to use alternatives to the private car.

The Order is being introduced as an experimental scheme so that the publics responses to it may be assessed over a trial period, before consideration is given to making the changes permanent.
