## Message from Lynn Johnson Interim Head of Market Management, Slough Borough Council.

The Adult Social Care Strategy was approved at Cabinet earlier this month and sets out the Council`s vision for working with people in Slough. <u>AGENDA ITEM (slough.gov.uk)</u>

It builds on work undertaken to date and describes the direction for Adult Social Care and how it intends to work with residents, people who use services and partners, including care providers, to deliver the Strategy.

The aim of the strategy is to help everyone know what to expect from Adult Social Care. It focuses on developing care and support options for all residents, in offering a proactive and partnership approach to prevention and early intervention.

The Strategy has been informed by feedback from engagement with partners and local people; residents told us about what is important to them; that we must work hard at engaging hard to reach communities to understand their needs and what works best for them and that they need a personalised and tailored approach to care and support.

Residents also told us that integration must mean more than with our health partners and must include all of our connections such as housing, the voluntary sector, people with lived experience, and others who have valuable contributions to make to the work of Adult Social Care in Slough.

We will monitor our progress in delivering the priorities in the strategy through the Adult Social Care Board.

#### **Infection Prevention Guidance**

Please don't forget, that from the **1st April 2024** the revised <u>Infection prevention and</u> <u>control guidance in adult social care: acute respiratory infection (ARI)</u> came into effect.

One of the key changes was the cessation of routine Covid testing of people being discharged from hospital settings to care homes.

#### **PPE Portal Closure**

The Department of Health and Social Care's scheme to provide free COVID-19 personal protective equipment (PPE) to health and care providers ended on 31 March 2024.

Due to this decision, the PPE Portal will be closed from **Thursday 23 May 2024.** Last order dates through the portal will be 23 May with the last delivery date occurring week commencing 27 May. **Click <u>here</u> to get to the PPE portal**

#### Market Position Statement (MPS) 2024/27

The MPS describes how the Covid-19 pandemic response and moving into recovery and learning to "live with covid" has allowed us to review what is important for Slough and enable us to build on what we have seen - great community spirit, people helping people, businesses helping businesses, service providers, staff and partners going the extra mile under unprecedented circumstances.

The development of our Market Position Statement has also been underpinned by our approach to prevention, delaying and reducing the need for traditional longer-term care and reducing the need for people to enter more acute settings.

The MPS outlines our key commissioning priorities and this will enable providers and partners currently operating in Slough, and those who may wish to in the future, to understand our requirements to collectively shape and develop a vibrant diverse market for current and future generations.

The aim is to help providers:

- Understand the future strategic direction of care and support and future commissioning intentions with an overview of the current people we support, and insights into the wider market.
- Make proactive business and investment decisions.
- Understand future demand; where there are gaps in the current offer; and where a change to the current provision may be required
- Work with us to develop the market and respond to individual needs and choices.

#### New resource for business continuity plan audit tool

Local Authorities and care providers can now access a **business continuity plan audit tool** that aims to consider how thoroughly cyber security and data protection issues are addressed as part of a business continuity plan.

## **Air Quality Action Plan**

Slough Borough Council is currently consulting on a draft, which sets out the measures the Council intends to take between 2024 and 2028 to address poor air quality within the borough.

This consultation is for all people who work, live, study and visit the Slough borough area. You may be interested to feedback of the impact of air quality on health and any possible barriers to using public transport and walking.

#### Free Data Security Toolkit support

The Data Security and Protection Toolkit (DSPT) helps adult social care providers in England to check and improve how they keep people's information safe. It is the official

self-assessment tool for the care sector and is widely recognised by CQC, local authorities and the NHS.

Please take a moment to watch the short animation.

The DSPT for social care is specifically designed for adult care providers and is nationally recognised as the official tool to evaluate compliance with legal requirements, data security standards and good practice.

If you have services funded by the NHS, for example under continuing healthcare, there is a contractual requirement to complete the DSPT every year.

Better Security, Better Care is a national and local support programme to help adult social care providers to store and share information safely. It covers paper and digital records and focuses on helping care providers to complete the Data Security and Protection Toolkit – the annual, online self-assessment.





As a care provider, the programme will help you to evaluate and improve your data and cyber security. This means you can reassure the people you support and their families, your staff, commissioners, regulators, and health and care partners, that you are following good practice – and meeting legal and regulatory requirements.
