THE BOROUGH OF SLOUGH WAITING RESTRICTIONS AND PARKING PLACES (CONSOLIDATION) ORDER 2017 (AMENDMENT NO. 43) ORDER 2024 (Order 67 of 2024) (PROPOSED ORDER)

Sections 1, 45, 46 and 53 of the Road Traffic Regulation Act 1984 and Regulation 7 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 as amended.

1. SLOUGH BOROUGH COUNCIL gives notice that it proposes to make an Order under sections 1, 45, 46 and 53 of the Road Traffic Regulation Act 1984 and any other enabling powers. The effects of the Order are set out below.
2. A new “CP2” parking zone would be created for parking in selected areas of the carriageway covering Albany Park, part of Bridge Street, Cottesbrooke Close, part of High Street, Colnbrook, Hunstanton Close, Mill Street, part of Park Street, Rudsworth Close, St. Thomas Walk and Vicarage Way together with the introduction of waiting restrictions operating at all times into certain sections of these roads.
3. The Order would introduce resident parking places and waiting restrictions operating on all days and at all times in sections of these roads.
4. It also introduces pay by phone short term parking places in sections of High Street, Colnbrook and Park Street operating on all days and at all times with a maximum stay time of 2 hours with no return within 1 hour.
5. It also introduces a disabled parking place in Village Way opposite the flank wall of No. 149 Vicarage Way operating on all days and at all times.
6. Properties eligible for the issue of permits are set out in the proposed Order.
7. The Order also proposes to introduce a new on street short term parking tariff band “E”. The charges under this band would be: up to 30 minutes parking: £1.00, up to 1 hour parking: £2.00 and up to 2 hours parking: £3.00.
8. Copies of the proposed Order, this notice and a statement of the Council's reasons for making the Order may be inspected free of charge at the Council's offices during normal working hours (excluding bank and public holidays). The objection must be made in writing, stating the grounds on which it is made, and must be sent so as to arrive no later than 21 days from the date of this Notice.
