STATEMENT OF REASONS

This Order creates the CP2 residents parking scheme to incorporate the following roads: Brookside, Drift Way, part of Horton Road, Moreland Avenue, Moreland Close, Popes Close, Rayners Close and Willow Close together with the introduction of waiting restrictions operating at all times into certain sections of these roads.

The purpose of this Order is to introduce a Controlled Parking Zone (CPZ) in line with the CPZ Borough Wide policy. This focuses on introducing CPZs as a standard approach for the provision of parking restrictions which would bring consistency in the management of road space and enable priority for parking to be given to residents and businesses.

The introduction of CPZs will enable the Council to:

- Prioritise parking for residents within the operational times using residents permits. Visitors vouchers will also be available
- Take account of the impact on the local amenities e.g. shops and schools
- Reduce congestion, obstructive and inconsiderate parking especially at junctions, bends and on footways
- Control the number of cars parking on the highway within CPZs
- Manage displacement parking
- Promote sustainability and improve air quality by encouraging commuters to use alternatives to the private car.
