### Training

The Department of Health and Social Care (DHSC) - The new Learning and Development Support Scheme (Information for all providers)

The DHSC has published a new guidance document on the funding available for learning and development for the adult social care workforce. This fund is called the Learning and Development Support Scheme.

<u>Learning and Development Support Scheme for the adult social care workforce: a guide for employers - GOV.UK</u>

The Learning and Development Support Scheme is administered via a new digital online claims service that allows adult social care employers to claim funding for certain training courses and qualifications on behalf of eligible care staff. Funding is available for eligible courses and qualifications that have been both paid for and started between 1 April 2024 and 31 March 2025 (inclusive).



In order to manage the roll-out, for the first few months access to the service will be via invite only but providers can complete an expression of interest form to be onboarded onto the new system, see below:

# Care Quality Commission (CQC) update for adult social care providers – Scam warning (Information for all Providers)

The CQC are aware of a scam where a company that claims to be CQC is emailing registered providers selling in-house training for staff on CQC inspections and how to get a rating of outstanding.

The email includes information copied from the CQC website and a fake CQC logo.

The CQC never charge a fee for any guidance, webinars and other face-to-face engagement events and they do not offer training for staff.

If you are considering investing in training for your staff, you should make sure the training provider is advertised as independent from CQC and let the CQC know of any examples of training companies that claim otherwise.

# REMINDER UK Health Security Agency (UKHSA) - Increased Norovirus Risk in Care Homes (Information for all Care Homes)

The 2024/2025 season has seen a high level of norovirus activity, which began earlier than usual. This is expected to result in increased outbreaks in care homes this winter.

A letter from the UK Health Security Agency (UKHSA) outlines the implications and recommendations for care homes.

### Letter regarding norovirus in care homes

This includes information on infection and prevention control (IPC), reporting outbreaks to Health Protection Teams, supporting resident health and wellbeing and guidance for supported living settings.

#### Reminder - When and how to use face masks

Care workers and visitors to care homes do not routinely need to wear a face mask



in care settings or when providing care in people's own homes.

However, Type IIR fluid-repellent surgical masks should be worn:

- if the person being cared for has symptoms of ARI
- when cleaning the room of a person with symptoms of ARI
- if there is an outbreak of ARI in a care home and the local risk assessment favours the introduction of universal masking as one of the outbreak control measures
- if the person being cared for would prefer staff or visitors to wear a mask while providing them with care or visiting

### **Spring 2025 COVID-19 Vaccination Programme**

NHS England have confirmed details of the COVID-19 vaccination programme for 2025. They are in the process of planning a spring campaign, with the following cohorts expected to be eligible for a seasonal vaccine:

- Adults aged 75 years and over
- Residents in a care home for older adults
- Individuals aged 6 months and over who are immunosuppressed

The spring campaign will run from the 1st of April 2025 and end on 17th June 2025. A minimum of 3 months is still required between doses of the vaccine.

NHS England have asked that priority be given to older adult care homes and eligible housebound patients.

The Contracts Management team reports on H&S building compliance every month to the council. Compliance will centre around the following:

- Asbestos
- Fire
- Electrics
- Gas (including Carbon Monoxide)
- Legionella
- Lifts / Lifting Equipment
- Building Safety
- Damp and Mould
- Electronic Gates
