

# LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

## The Slough Borough Council (Reorganisation of Community Governance) (Amendment Order) 2019

*Made 22 January 2019*

*Coming into force in accordance with article 1(2)*

Slough Borough Council (“the Council”), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 c.28 (“the 2007 Act”), has undertaken a community governance review and made recommendations dated 27<sup>th</sup> November 2018.

The Council decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, made the Slough Borough Council (Reorganisation of Community Governance) Order 2019 dated 15<sup>th</sup> January 2019 (“the Order”).

The Council makes the following Order in exercise of the powers conferred by sections 86(5)(a) of the 2007 Act to vary or revoke a provision of the Order previously made.

### **Citation and commencement**

1.—(1) This Order may be cited as the Slough Borough Council (Reorganisation of Community Governance) (Amendment) Order 2019 (“the Amendment Order”).

(2) It shall come into effect the day after the Amendment Order is made.

### **Interpretation**

2. In this Order—

“the Amendment Order” means this Order;

“Borough” means the borough of Slough;

“the Order” means the Slough Borough Council (Reorganisation of Community Governance) Order 2019.

### **Effect of Order**

3. The Order is amended as follows.

### **Amendments to Article 1**

4. In Article 1 (citation and commencement), article 1(2) should be amended in the following way, as if—

(a) 8(3) is substituted with 7(3);

(b) 8(4) is substituted with 7(4); and

(c) after Article 7(4) “and 7(5)” is inserted.

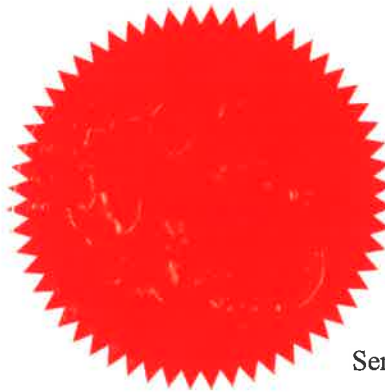
### **Amendment to Article 9**

5. Article 9 shall be re-numbered as Article 8.

**Order date**

6. The date referred to in Article 1(2) shall be the date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Amendment Order amends the Slough Borough Council (Reorganisation of Community Governance) Order 2019.

Article 4 amends the references to articles referred to within Article 1(2) of the Order, substituting Articles 8(3) and 8(4) for Articles 7(3) and 7(4). In addition, Article 7(5) is to be inserted following Article 7(4).

Article 5 amends Article 9 to become instead Article 8.
