

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The Slough Borough Council (Reorganisation of Community Governance) Order 2019

Made 15 January 2019

Coming into force in accordance with article 1(2)

Slough Borough Council (“the Council”), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 c.28 (“the 2007 Act”), has undertaken a community governance review and made recommendations dated 27th November 2018:

The Council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The Council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The Council makes the following Order in exercise of the powers conferred by sections 86, 88(2)(c), 97, 98(3), 98(4) and 240(10) of the 2007 Act and all other enabling powers.

Citation and commencement(a)

1.—(1) This Order may be cited as the Slough Borough Council (Reorganisation of Community Governance) Order 2019.

(2) It shall come into force on 1st April 2019, except for Articles 8(3) and 8(4) which shall come into effect the day after the Order is made.

Interpretation

2. In this Order—

“Borough” means the borough of Slough;

“Existing” means existing on the date this Order is made;

“Maps” mean the maps marked “Map referred to in the Slough Borough Council (Reorganisation of Community Governance) Order 2019” and attached to this Order and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;

“Registration Officer” means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

Effect of Order

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

Dissolution of Parish Council for the parishes of Wexham Court and Britwell

4. The parish councils for the parishes of Wexham Court and Britwell shall be wound up and dissolved.

Abolition of the parishes of Wexham Court and Britwell

5. The parishes of Wexham Court and Britwell as shown on the Maps referred to in Article 2 shall be abolished and become part of the unparished area of the Borough.

Electoral register

6. The Registration Officer for the Borough shall make such rearrangement of, or adaptation of, the Existing register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

Transfer of property, rights and liabilities

7. – (1) All Existing funds and balances, land, property, staff, pensions, rights and liabilities not limited to those described in Schedules 1 - 4 shall transfer from Wexham Court Parish Council and Britwell Parish Council to Slough Borough Council on the date specified in column (2) of those Schedules.

(2) As a consequence of any such transfer specified in Article 7(1) Slough Borough Council shall be treated as the same person in law as the Parish from which the transfer is made, from the date so specified.

(3) The parish councils of Wexham Court and Britwell shall be obliged to permit Slough Borough Council to inspect all land, premises, facilities, books, records, bank or investment account statements, contracts, leases, licences, bookings diaries and any other information, asset, right or liability that is necessary or proper for the purposes of, or in consequence of, or to give full effect to, this order.



(4) The parish councils of Wexham Court and Britwell shall be required to disclose details of all land, assets and real or personal property that each of them own and any rights, liabilities, claims or legal proceedings by the parish council or to which it is subject, to Slough Borough Council.

(5) Both Wexham Court and Britwell parish councils shall be required to respond promptly and fully to all and any other reasonable requests for information from Slough Borough Council.

Order date

9. 1st April 2019 is the Order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order gives effect to recommendations made by Slough Borough Council for the dissolution and abolition of the parishes of Wexham Court and Britwell within the borough of Slough.

The parishes of Wexham Court and Britwell will be abolished with effect from 1 April 2019.

Article 6 obliges the Electoral Registration Officer to make any necessary amendments to the electoral register to reflect the new electoral arrangements.

Article 7 contains details of funds and balances, land, property, staff, rights and liabilities described in the Schedules that shall transfer from the Parish Councils defined within this Order on the date specified in those Schedules.

The Maps defined in article 2 show the parishes of Wexham Court and Britwell which shall be abolished and the property transferred to the Borough pursuant to this Order. It is available, at all reasonable times, at the offices of Slough Borough Council.

The Parish of Colnbrook with Poyle will remain unaltered.

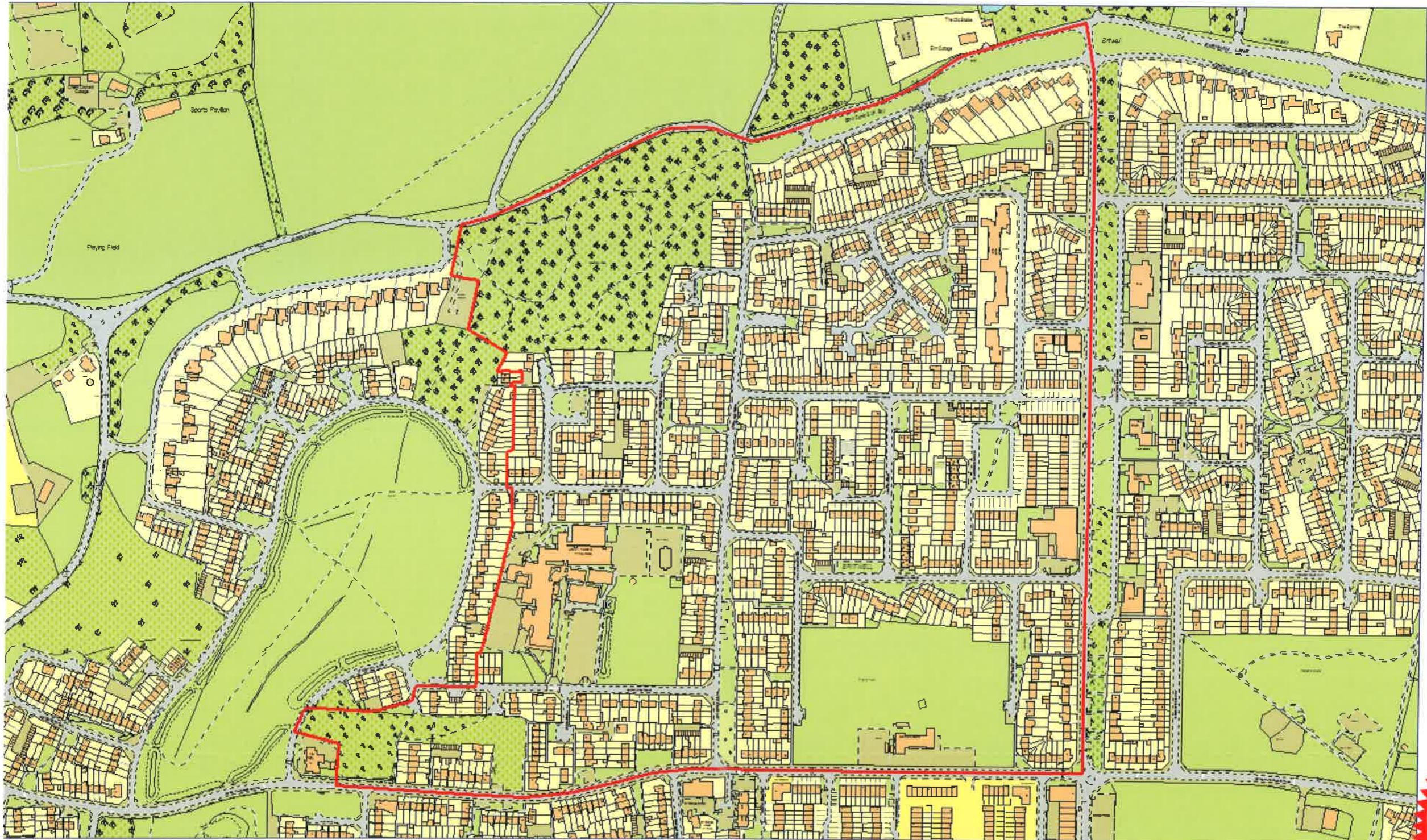


MAP REFERRED TO IN THE SLOUGH BOROUGH COUNCIL
